The women's rights movement is a feminist movement, where women strive to get what men have but what women have been denied. Women and men can both stand for this movement. Women's rights leaders have encouraged many women and men to join women's rights movements. The movement fighting for women's rights to vote is called women's suffrage. While there has been immense progress, many countries still deny women their basic rights.

## Text 2 (20 marks)

A. Child migration is the movement of people of ages 3-18, with or without their parents or a legal guardian, to another country or region. Child migration is a significant contemporary phenomenon. It is likely to increase as the mobility of young people grows; a result of more affordable travel, climate change, growing technology mediated connectivity, increasing global inequality in the distribution of opportunity, and security and access to employment. Much of this migration is unproblematic. After a period of adjustment to a new context, most children, along with their families, integrate into their new societies.

B. However, child migration does not always conform to that pattern - migration can be unsafe, irregular, and exploitative. Over the centuries, both male and female children have been separated from their families by wars, famine and environmental disaster; or have been trafficked and transported from home by exploitative masters (slave owners, religious orders, warlords).

C. One reason for recent increased attention to child migration is its current magnitude. There were 37.9 million migrants under the age of 20 in 2019, which was 14 per cent of the world's migrants. This reality has urgent implications for educational, child welfare and migration authorities. Dramatic impacts for children also flow from other migration-related contexts: the absence of life-saving rescue procedures to prevent child drowning or fatal dehydration during migration journeys; educational shortcomings in refugee camps; migrant child sexual exploitation; and unmet physical and mental health needs for displaced children.

D. Large-scale child migration inevitably places complex demands on States. Some State services, such as education, are essential for all migrant children. States are primarily mandated to provide education to all children in their jurisdiction without discrimination. The States should accurately identify the educational needs of migrant or refugee children, taking account of their prior educational experience and their linguistic competencies.

E. Alongside these continuing challenges, several significant regional initiatives on child migration have been developed in recent years. Three are noteworthy - those in the European Union, in West Africa and in Latin America. The European Court of Human Rights has played an important role, by ruling against the detention of migrant children, and preventing family expulsions with far-reaching consequences for the care or wellbeing of affected children. The West African Network (WAN), is specifically geared to generating protective interventions for the benefit of child migrants in the region, particularly those travelling unaccompanied. Among various regional initiatives in Latin America, the most notable is the Inter-American Court of Human Rights 2014 Advisory Opinion on the needs of children in international migration, which describes applicable procedures relevant to the treatment of both asylum-seeking and irregular child migrants. Mexico has taken a lead in implementing protective services for unaccompanied child migrants, including those returned by the United States.
